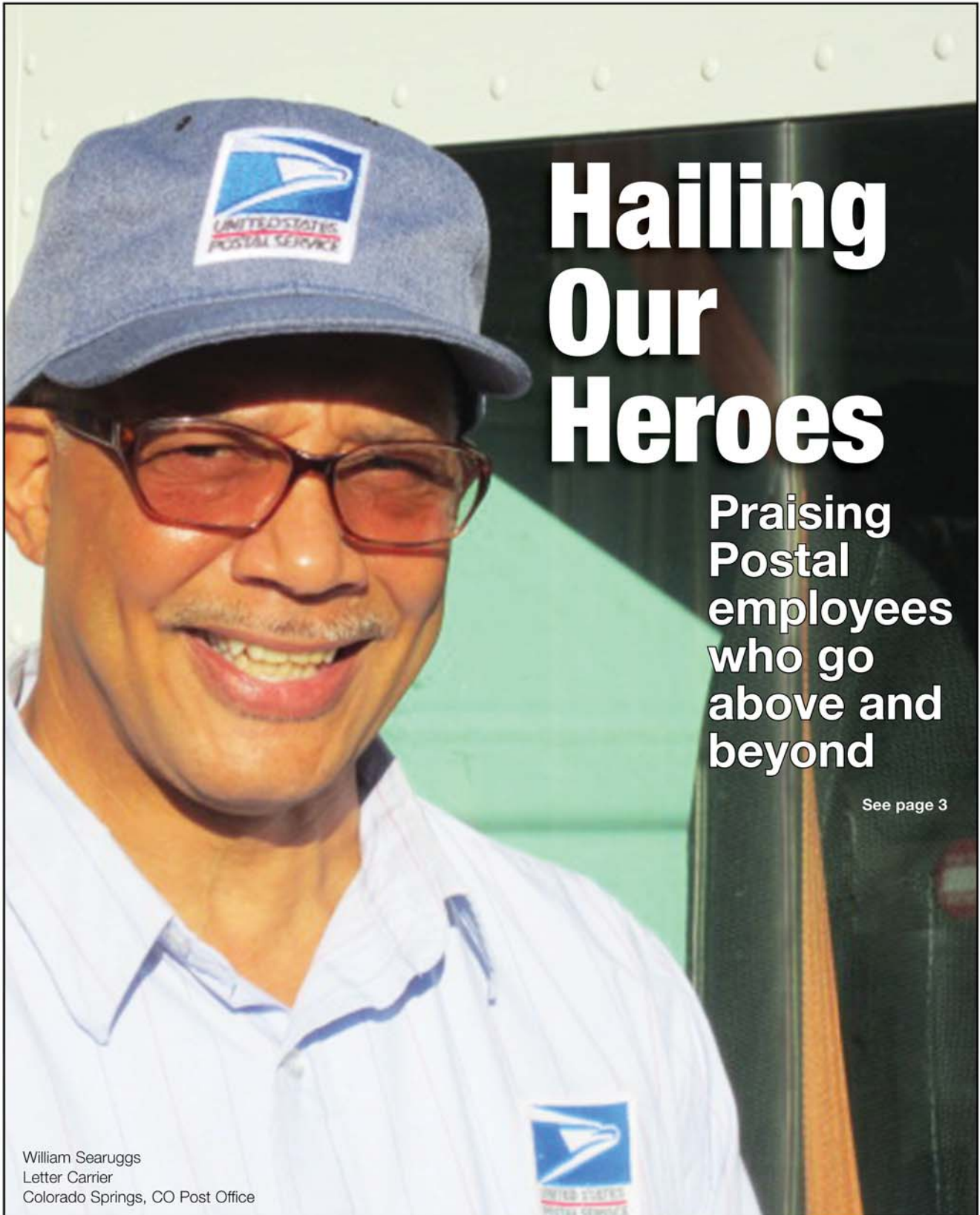

Honoring Heroes: William Searuggs, Letter Carrier

Colorado Springs, CO, Letter Carrier William Searuggs was recently hailed as a hero for coming to the aid of a customer who fell and hit his head.

Searuggs was delivering mail to a home when he spotted blood near the front door. "As I proceeded to put mail in the box, that's when I heard (someone) scream, 'Help, help. Come in, come in,'" Searuggs told the local CBS TV station.

Searuggs, who has been delivering mail for about 15 years, entered the house and found 86-year-old Max Patterson lying on the floor. Patterson had fallen outside, hit his head, and crawled back inside.

Searuggs helped Patterson get into a chair, used a kitchen towel to apply pressure to the wound, and called 911. He stayed with Patterson until emergency personnel arrived.

Patterson's family said they expect him to recover. Neighbors called Searuggs a hero — a label he resists.

"Not so much a hero, just me getting him the help he needed," Searuggs said.

Searuggs is one of many employees who have been recognized through the Postmaster General Heroes Program.

The program, established in 2003, is based upon a simple idea: Postal Service™ employees know their customers' habits and are often the first to notify emergency personnel when they notice something wrong.

Employees must be nominated for the PMG Hero Award. Nominations are reviewed by Corporate Communications for accuracy and sent for approval to the Office of the Inspector General and the Inspection Service. Following approval, nominees receive a "thank you" letter from Postmaster General Megan Brennan and are featured in the Postal Service's daily publication, *Link*.

To nominate an employee, complete PS Form 400, *Corporate Communications PMG Hero Nomination*. To download or print the form, go to *Blue* and select Essential Links, then choose Forms. Email completed forms to PMG_HeroNominations@usps.gov.

The National Association of Letter Carriers also pays tribute to select members through its Heroes of the Year Awards, which have been presented annually since 1974.

DMM Revision: New Flats Sequencing System (FSS) Sortation Level

Effective July 13, 2015, the Postal Service™ will revise *Mailing Standards of the United States Postal Service*, Domestic Mail Manual (DMM®) section 708.1.4 to add a new FSS sortation level. This revision is a result of the FSS DMM revisions announced in the May 14, 2015, *Postal Bulletin*, that were effective May 31, 2015. The abbreviation for the new FSS sortation level will be FSF.

Although this clarification will not be published in the DMM until July 13, 2015, this revision is effective immediately.

Effective June 11, 2015, the Postal Service™ is revising the *Employee and Labor Relations Manual* (ELM) subchapter 510 to update policies regarding leave accrual for certain Postmasters and EAS Employees.

511.31 Covered

Notes: Transitional employees are not covered by the leave program, but do earn leave as specified in their union's national agreement.

References to A–E Postmasters also apply to Part-Time Postmasters.

512.311 Full-Time Employees

[Revise the text of 512.311a to read as follows:]

The following provisions concern full-time employees:

- a. *Accrual Chart.* Full-time career employees earn annual leave based on their number of creditable years of service as follows:

Table 1: Table 1 is valid only for:

- (1) Career bargaining employees, and
- (2) Career non-executive non-bargaining employees except for those listed under Table 2.

Leave Category	Creditable Service	Maximum Leave Per Year
4	Less than 3 years	4 hours for each full biweekly pay period; i.e., 104 hours (13 days) per 26-period leave year.
6	3 years but less than 15 years	6 hours for each full biweekly pay period plus 4 hours in last full pay period in calendar year; i.e., 160 hours (20 days) per 26-period leave year.
8	15 years or more	8 hours for each full biweekly pay period; i.e., 208 hours (26 days) per 26-period leave year.

Table 2: Table 2 is valid only for newly hired career Postmasters and supervisory or managerial non-bargaining employees, and non-career employees converted to those positions, with a career appointment date on or after October 6, 2012, who are without any prior federal or USPS service that was creditable at the time of that career appointment toward the leave computation date, and only while holding a career Postmaster, supervisory, or managerial non-bargaining position. Table 2 never applies to an employee who earned annual leave per Table 1.

512.312 Part-Time Employees

[Revise the text of 512.312b(3), item a, to read as follows:]

Exceptions: The following are exceptions to the crediting rule in 512.312b.

- (a) Part-time regular schedule employees including A–E Postmasters are credited with annual leave on a pro rata basis, according to their authorized daily schedules. Employees other than A–E Postmasters must wait until they have 1 year or more of career service to be credited at the beginning of the leave year with the annual leave that they will earn during the leave year. A–E Postmasters are credited at the beginning of the leave year with the annual leave that they earn during the leave year. Part-time regular employees are entitled to additional leave hours, based on their leave category, for each (1) 20, 13, or 10; or (2) 26, 17.33, or 13 hours of work in excess of the schedule (see Exhibit 512.312).

Recording Hours for Annual and Sick Leave

- Units of hours in a pay status are converted into annual leave credits at the rate of 1 hour for each unit of 20, 13, or 10 hours in a pay status — up to a maximum of 4, 6, or 8 hours per biweekly pay period, depending on the employee's leave category.
- Hours in a pay status in excess of these whole units are accumulated and carried forward as excess workhours. These excess (uncredited) workhours are added to hours in a pay status in the next period.
- Whole units of creditable hours (20, 13, or 10) are then converted into leave hours at the unit rate — provided no more leave is credited to a part-time employee than could be earned in the same leave year by a full-time employee.
- The maximum credit allowable for a particular leave category is calculated by multiplying the period number by the number of leave hours allowable per period.

Table 2: Table 2 is valid only for newly hired career Postmasters and supervisory or managerial non-bargaining employees, and non-career employees converted to those positions, with a career appointment date on or after October 6, 2012, who are without any prior federal or USPS service that was creditable at the time of that career appointment toward the leave computation date, and only while holding a career Postmaster, supervisory, or managerial non-bargaining position. - b. Hours in a pay status in excess of these whole units are accumulated and carried forward as excess workhours. These excess (uncredited) workhours are added to hours in a pay status in the next period.
- c. Whole units of creditable hours (26, 17.33, or 13) are then converted into leave hours at the unit rate — provided no more leave is credited to a part-time employee than could be earned in the same leave year by a full-time employee.
- d. The maximum credit allowable for a particular leave category is calculated by multiplying the period number by the number of leave hours allowable per period.

Handbook M-41 Revision: On Route

Effective June 11, 2015, the Postal Service™ is revising Handbook M-41, *City Delivery Carriers Duties and Responsibilities*, to update the policies regarding the handling of Certified Mail®.

With the ability to automate a large degree of the current mail handled by carriers, the Postal Service has been testing the ability to automate the Certified Mail flow. This test

has proven to be very successful in isolating Certified Mail for the carriers. The Postal Service will implement a process which will capture and hold out the Certified Mail for each carrier route and create a manifest for each route. This Certified Mail will be presented to the carriers with their residual mail at their case.

Non-automated Certified Mail will also be presented to the carriers with the manually sorted mail through the manual distribution case. The Certified Mail will still be listed on PS Form 3867, *Account Mail Matter Received for Delivery*. The carrier will inform the accountable clerk when the clerk issues other accountable mail and/or keys to the carrier and is cleared through the same process currently used.

EAS Privately-Owned Vehicle Program

The EAS Privately-Owned Vehicle Program is now available for eligible supervisors and Postmasters who use their privately-owned vehicle to perform street supervision, travel between Post Offices™, or perform certain other work-related tasks. The Program is strictly voluntary; no employee is required to participate.

Employees who participate in the Program will receive two important benefits. Participating employees will be reimbursed through eTravel for the added expense (up to \$1,000 per year) of adding a commercial or business-use policy or rider to their existing car-insurance policies. Employees will also be reimbursed for their actual mileage.

Not all employees are eligible to participate. Eligibility is currently limited to two job categories: (1) Field EAS who regularly perform street supervision, and (2) Postmasters and supervisors who must drive to or between Post Offices. Employees within one of these two categories must also satisfy four other prerequisites: the employee

must (a) meet Postal Service™ criteria for driving positions, (b) possess a valid driver's license, (c) own a vehicle fit for the expected driving, and (d) possess an insurance policy for his or her privately-owned vehicle. Finally, participation is only for EAS employees who serve an identifiable business need.

Employees who meet these criteria may be enrolled in the Program beginning on June 1, 2015. Employees and managers who want to know more about the Program should consult Management Instruction FM-640-2015-1. International Updates: National Recertification for Mailers Privately Printing Customs Declaration Forms

The U. S. Postal Service® is mandating a national recertification for mailers and vendors who have previously been approved to privately print customs declaration forms for international and/or domestic mail that requires a customs declaration form. The recertification process includes customs barcode range validation, updated data requirements, and a new harmonized customs label format.

2015 Profile Update Was Due by May 31, 2015:

Mailers currently authorized by the USPS® to privately print customs declaration forms must complete the Mailer Profile Update Form available on RIBBS at <https://ribbs.usps.gov/index.cfm?page=intcustomsforms> and submit to USPS Global Trade Compliance at globaltrade-compliance@usps.gov.

For mailers using Priority Mail Express International® (PMEI), all customs form numbers previously assigned for use will be phased out and replaced with new “E” series numbers designated specifically for this product.

For mailers using International Priority Airmail® (IPA®) and International Surface Air Lift® (ISAL®), all previously assigned “L” series customs form numbers will be phased out and replaced with new “U” series customs form numbers.

If a mailer fails to update his or her profile, the mailer will no longer be considered authorized by the USPS to privately print customs declaration forms.

Data Transmission Requirements are Effective June 29, 2015:

If you are printing customs labels from a software provider, you will need to contact your provider for a software update. USPS is working with certified providers to have software updates available.

IPA and ISAL item-level electronic customs data will be required to be assigned specific receptacles. The Shipping Services File (SSF) versions 1.7 and higher are being updated to facilitate this submission.

Transmission of electronic customs data will be required for mailers shipping to Army Post Offices (APOs), Fleet Post Offices (FPOs), Diplomatic Post Offices (DPOs), and non-military addresses in overseas U.S. Possessions, Territories, and Freely Associated States.

Customs Declaration Forms

Effective July 30, 2015, all mailers will be required to use the new harmonized customs declaration forms for the PS Form 2976, *Customs Declaration CN-22 – Sender’s Declaration*; the PS Form 2976-A, *Customs Declaration and Dispatch Note – CP-72*; and the PS Form 2976-B, *Priority Mail Express International Shipping Label and Customs Form*.

This new design is a cross-border effort to allow posts to offer a reliable, tracked, end-to-end delivery service with participating countries.

The release of the new harmonized label supersedes all previous notifications and exceptions.

The option to print single-ply customs declaration forms, PS Form 2976-A and PS Form 2976-B, is available for select countries and APO/FPO/DPO destinations.

Guidelines for Privately Printed Customs Declaration Forms is available on RIBBS at <https://ribbs.usps.gov/index.cfm?page=intcustomsforms>.

Note: As part of the certification process, you will be required to create the new forms and submit them to National Customer Support Center (NCSC) for approval before using the new forms in production.

If a mailer fails to obtain recertification to privately print USPS customs declaration forms, that mailer’s shipments may be delayed or returned to sender. If a certified mailer does not validate assigned ranges, use certified labels and barcodes, or provides incorrect or incomplete customs data, the mailer will be subject to mail refusal at a USPS acceptance facility.

Customers are encouraged to submit materials to the NCSC for certification as quickly as possible.

In accordance with 39 U.S.C. 3401(a)(1)(B), free mail privileges will also be extended to individuals hospitalized for disease or injury in a facility under the jurisdiction of the Armed Forces as a result of service in these designated areas. Personnel who are authorized to receive this privilege may mail — without postage — letters, postcards, and sound recordings (audio or video recordings) having the character of personal correspondence to any place in the United States, to any U.S. possession or territory, or to any military Post Office™ (APO/FPO).

Free mail originating from the above overseas locations should have a complete APO or FPO return address, the word “Free” in the upper right corner, and a complete delivery address. In most cases, the mailpiece will also exhibit an APO or FPO postmark. Free mail receives First-Class Mail® service; however, it may not receive Registered Mail™ service, Certified Mail® service, or insurance.

All employees who handle and deliver mail should be made aware of this free mail privilege. Do not collect postage upon delivery; do not return this mail to the sender for postage. Mail having the appearance of free mail under this program should never be returned to sender.

Verifying U.S. Postal Service Money Orders

Follow these steps to cash a Postal Service™ money order:

1. Check that the amount does not exceed the legal limit: \$1,000 for domestic, and \$700 for international postal money orders.
2. Check that the proper security features are present:
 - When held to the light, a watermark of Benjamin Franklin is repeated from top to bottom on the left side.
 - When held to the light, a dark line (security thread) runs from top to bottom with the word “USPS” repeated.
 - There should be no discoloration around the dollar amounts, which might indicate the amounts were changes.

3. If the money order seems suspicious, call the U.S. Postal Service Money Order Verification System at 866-459-7822.

A. Securities, currency, or precious metals in their raw, unmanufactured state are prohibited. Official shipments are exempt from this restriction.

A1. Mail addressed to "Any Servicemember," or similar wording such as "Any Soldier," "Sailor," "Airman," or "Marine"; "Military Mail"; etc., is prohibited. Mail must be addressed to an individual or job title such as "Commander," "Commanding Officer," etc.

A2. APO/FPO/DPO addresses shall not include a city and/or country name.

B. Regardless of mail class, a customs declaration (PS Form 2976 or, if the customer prefers, PS Form 2976-A) is required for all items weighing 16 ounces or more or any item (regardless of weight) containing potentially dutiable mail contents (e.g., merchandise or goods) addressed to or from an APO, FPO, or DPO ZIP Code. No customs form is required for items weighing less than 16 ounces when the contents are not potentially dutiable (e.g., documents). The surface area of the address side of the mailpiece must be large enough to contain the applicable customs declaration. The following exceptions apply:

- Known mailers are exempt from providing customs documentation on non-dutiable letters or printed matter. (A known mailer is a business mailer who enters volume mailings through a business mail entry unit (BMEU) or other bulk mail acceptance location, pays postage through an advance deposit account, uses a permit imprint for postage payment, and submits a completed postage statement at the time of entry that certifies that the mailpieces contain no dangerous materials that are prohibited by postal regulations.)
- All federal, state, and local government agencies whose mailings are regarded as "Official Mail" are exempt from providing customs documentation on any item addressed to an APO, FPO, or DPO except for those APOs/FPOs/DPOs to which restriction "B2" applies.
- Prepaid mail from military contractors is exempt, providing the mailpiece is endorsed "Contents for Official Use — Exempt from Customs Requirements."

B2. All federal, state, and local government agencies must complete customs documentation when sending potentially dutiable mail addressed to or from this APO, FPO, or DPO.

C. Cigarettes and other tobacco products are prohibited.

C1. Obscene articles, prints, paintings, cards, films, videotapes, etc., and horror comics and matrices are prohibited.

D. Coffee is prohibited.

E. Medicines (prescription, over-the-counter, vitamins, and supplements) are prohibited when mailed to individuals for human or animal use. This prohibition does not apply when medicines are sent as official mail only between specifically designated agencies such as pharmaceutical distributors, hospitals, clinics, and pharmacies.

E1. Medicines or vaccines not conforming to French laws are prohibited.

E2. Any matter depicting nude or seminude persons, pornographic or sexual items, or nonauthorized political materials is prohibited. Although religious materials contrary to the Islamic faith are prohibited in bulk quantities, items for the personal use of the addressee are permissible.

E3. Radio transceivers, cordless telephones, global positioning systems, scanners, base stations, and handheld transmitters are prohibited.

F. Firearms of any type are prohibited in all classes of mail. See definitions of firearms in PUB 52, Sec. 431. This restriction does not apply to firearms mailed to or by official U.S. government agencies. The restriction for mail to this APO/FPO/DPO ZIP Code does not apply to firearms mailed from this APO/FPO/DPO ZIP Code, provided ATF and USPS regulations are met. Antique firearms are a separate category defined in PUB 52, Sec. 431.3 and ATF regulations; they do not require an ATF form.

F1. Privately owned weapons addressed to an individual are prohibited in any class of mail.

F2. Importation of firearms is restricted to one shotgun and one single shot .22 caliber rifle per individual.

G. Only letters, flats, and Periodicals are authorized. Parcels of any class are prohibited.

H. Meats, including preserved meats, whether hermetically sealed or not, are prohibited.

H1. Pork or pork by-products are prohibited.

I. Mail of all classes must fit in a mail sack. Mail may not exceed the following dimensions:

- Maximum length 20 inches.
- Maximum width 12 inches.
- Maximum height 12 inches.

The maximum length and girth combined may not exceed 68 inches.

This restriction does not apply to registered mail and official government mail marked MOM.

I1. This restriction does not apply to registered mail.

I2. This restriction does not apply to official government mail marked MOM.

J. Parcels may not exceed 108 inches in length and girth combined.

K. Mail that includes in the address the words, "Dependent Mail Section," may consist only of letter mail, newspapers, magazines, and books. No parcel of any class containing any other matter may be mailed to the Dependent Mail section. This restriction does not apply if the address does not include the words "Dependent Mail Section."

L. All official mail is prohibited.

M. Fruits, vegetables, animals, and living plants are prohibited.

N. Registered mail is prohibited.

O. Delivery status information for Extra Services is not available on USPS.com.

P. APO is used for the receipt and dispatch of official mail only.

Q. Mail may not exceed 66 pounds, and size is limited to 42 inches maximum length and 72 inches maximum length and girth combined.

R. All alcoholic beverages, including those mailable under PUB 52, Sec. 421, are prohibited.

R1. Materials used in the production of alcoholic beverages (i.e., distilling material, hops, malts, yeast, etc.) are prohibited.

S. Mail of all classes must fit in a mail sack. Mail may not exceed the following dimensions and weight:

- Maximum length 12 inches.
- Maximum width 12 inches.
- Maximum height 5 1/2 inches.
- Maximum weight 25 pounds.

The maximum length and girth combined may not exceed 47 inches.

T. Mailings of case lots of food and supplemental household shipments must be approved by the sender's parent agency prior to mailing.

U. Parcels must weigh less than 16 ounces when addressed to Box R. This restriction does not apply to mail endorsed "Free Matter for the Blind or Handicapped."

U1. Mail is limited to First-Class Mail weighing 13 ounces or less when addressed to Box R. This restriction does not apply to mail endorsed "Free Matter for the Blind or Handicapped." Videotapes are prohibited when addressed to Box R, regardless of weight.

U2. Mail is limited to First-Class Mail letters only when addressed to Box R.

U3. Mail is limited to First-Class Mail correspondence (including voice and video cassettes), newspapers, magazines, photographs, not exceeding 16 ounces, when addressed to Box R.

U4. Mail addressed to Box C is limited to 2 pounds, regardless of class.

V. Priority Mail Express Military Service (PMEMS) not available from any origin.

V1. USPS Tracking is not available.

W. Meat products, such as dried beef, salami, and sausage, may be mailed, provided they remain in their original, hermetically sealed packages and bear USDA certification. Other meats, bones, skin, hair, feathers, horns or hoofs of hoofed animals, wool samples, tobacco leaves, including chewing and pipe tobacco, snuff, cigars, and cigarettes, or obscene material, including obscene drawings, photographs, films, and carvings, are prohibited. Exception: 200 grams of tobacco per parcel are permitted duty free.

X. Personal mail is limited to First-Class Mail items (to include audio cassettes and voice tapes) weighing 13 ounces or less. This limitation does not apply to official mail.

Y. Mail is limited to First-Class and Priority Mail items only. All Periodicals, Standard Mail items, and Package Services items (including SAM and PAL) are not authorized. This restriction also applies to official mail.

Z. No outside pieces (OSPs).

Z1. The following restriction is applicable only to International Service Centers (ISC)/Exchange Offices. An Anti-Pilferage Seal (Item No O817E or O818A) is required on all pouches and sacks.

Freely Associated States (FAS) Restrictions

Effective March 19, 2015, the mailing restrictions for Freely Associated States will be listed in the Pull-Out section of the *Postal Bulletin* and updated periodically.

Freely Associated States

Mail addressed to freely associated states is subject to certain conditions or restrictions of mailing regarding content, preparation, and handling. Pictorial Postmarks Announcement

As a community service, the Postal Service™ offers pictorial postmarks to commemorate local events celebrated in communities throughout the nation. A list of events for which pictorial postmarks are authorized appears below. The sponsor of the pictorial postmark appears in italics under the date. Also provided are illustrations of these postmarks.

People attending these local events may obtain the postmark in person at the temporary Post Office™ station established there. Those who cannot attend the event but who wish to obtain the postmark may submit a mail order request. Pictorial postmarks are available only for the dates indicated, and *requests must be postmarked no later than 30 days following the requested pictorial postmark date.*

All requests must include a stamped envelope or postcard bearing at least the minimum First-Class Mail® postage. Items submitted for postmark may not include

postage issued after the date of the requested postmark. Such items will be returned unserved.

Customers wishing to obtain a postmark should affix stamps to any envelope or postcard of their choice, address the envelope or postcard to themselves or others, insert a card of postcard thickness in envelopes for sturdiness, and tuck in the flap. Place the envelope or postcard in a larger envelope and address it to: Pictorial Postmarks, followed by the Name of the Station, Address, City, State, ZIP+4® Code, as listed below.

Customers can also send stamped envelopes and postcards without addresses for postmark, as long as they supply a larger envelope with adequate postage and their return address. After applying the pictorial postmark, the Postal Service returns the items (with or without addresses) under addressed protective cover.

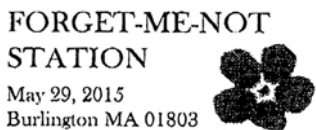

How to Order the First-Day-of-Issue Digital Color or Traditional Postmarks

Customers have 60 days to obtain the first-day-of-issue postmarks by mail. They may purchase new stamps at their local Post Office™, by telephone at 800-STAMP-24, or at The Postal Store® website at www.usps.com/shop.

Traditional Postmarks

Customers should affix the stamps to envelopes of their choice, address them to themselves or others, or provide a self-addressed return envelope with sufficient postage large enough to accommodate the canceled item. Mail the request to the corresponding city of issuance. There is no charge for the first 50 postmarks. There is a 5-cent charge for each additional postmark over 50. Customers should submit a check, money order, or credit card for payment. After applying the first-day-of-issue postmark, the Postal Service™ will return the envelopes to the customer by U.S. Mail.

All postmark requests should go to the first-day-of-issue city. The first-day-of-issue city Post Office will then forward in bulk all postmark requests to Cancellation Services, Stamp Fulfillment Services, PO Box 449992, Kansas City, MO 64144-9992 by respective Post Offices.

Digital Color Postmarks

Only select stamp issues offer a digital color postmark. Customers may submit #6 or #10 envelopes constructed of paper rated as "laser safe." The Postal Service recommends envelopes of 80-pound Accent Opaque, acid-free, 9/16" side seams with no glue on the flap. The maximum

size of all digital color postmarks is 2" high x 4" long. Allow sufficient space on the envelope to accommodate the postmark. Do not use self-adhesive labels for addresses on the envelope. Two test envelopes must be included. There is a minimum of 10 envelopes at 50 cents per postmark required at the time of servicing. Customers should submit a check, money order, or credit card for payment.

The Postal Service reserves the right to not accept hand-painted and other cachet envelopes that are not compatible with our digital color postmark equipment. The Postal Service also reserves the right to substitute traditional black rubber postmarks if use of nonspecified envelopes results in poor image quality or damage to equipment.

Customers should affix the stamps to the envelopes and address them to themselves or others for return through the mail. Or, they may include an additional self-addressed return envelope, large enough to accommodate their canceled items, with sufficient postage affixed for return of their postmarked items. Mail the request for a first-day-of-issue digital color postmark to the corresponding city of issuance. Post Offices will then forward all customer requests for digital color postmarks to Cancellation Services, Stamp Fulfillment Services, PO Box 449992, Kansas City, MO 64144-9992.

After applying the first-day-of-issue postmark, the Postal Service will return the envelopes to the customer by U.S. Mail.

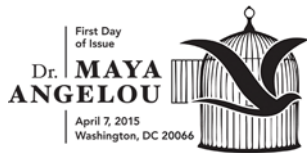

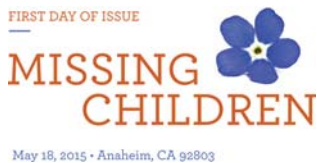
