Dear Vance:

This is in response to the Union's letter dated April 18, requesting "a two-week moratorium on processing of grievances, disciplinary actions and arbitration hearings at the national, regional, state and local levels" for the period of Monday, August 13 to Monday, August 27 due to the American Postal Workers Union's National Executive Board Meeting, Educational Seminar, Craft Conferences, Biennial National Convention and related meetings.

The Postal Service agrees with your request as follows:

Time limits for filing grievances and appeals to arbitration will be extended for a period of 15 days beyond those specified in the National Agreement. In addition, suspensions that would otherwise be served because no grievance had been filed within 14 days or because no appeal had been filed to the next step of the grievance-arbitration procedure will be deferred for the 15-day extension period.

No arbitrations will be scheduled between August 13 and August 27
