Certification of Results

Pursuant to a letter agreement dated August 12, 2019 and signed by Elizabeth Powell, Secretary/Treasurer of the American Postal Workers Union, AFL-CIO, hereinafter referred to as 'APWU," the American Arbitration Association, hereinafter referred to as the "Administrator," agreed to conduct an Election of Officers.

One hundred ninety thousand three hundred eighty-two (190,382) ballots were mailed to eligible voters on September 11, 2019.

APWU provided the Administrator with a list of persons who were eligible to vote. To be counted, ballots had to be received by the Administrator from the United States Postal Service no later than 2:00 p.m. on Monday, October 7, 2019.

The Administrator received thirty six thousand one hundred ninety (36,190) business reply envelopes on Monday, October 7, 2019. During the course of the election, nine hundred ninety-one (991) duplicate ballots were mailed out at the request of APWU members.

Of the thirty six thousand one ninety (36,190) business reply envelopes received 17 members returned both a duplicate and original business reply envelope. As a result, 17 original business reply envelopes were voided with the duplicate being included in the final envelope count. Therefore, the total number of verified business reply envelopes totaled 36,173.

In addition, forty seven (47) ballots were not counted for the following reason:

39 envelopes did not include any identifying information 8 secret envelopes returned in single overnight envelope

The eligibility verification and tabulating of ballots took place at the Embassy Suites by Hilton, 900 10th Street NW, Washington, DC 20001 on Monday, October 7, 2019 and Tuesday, October 8, 2019 in the presence of observers and the election committee.

Secrecy of the ballots was maintained at all times. The results are hereby certified as appended hereto.
