## **U.S. Postal Service Board of Governors to Meet Nov. 14** *Financial Briefing to Follow Open Session Meeting*

WASHINGTON — The U.S. Postal Service Board of Governors will meet Nov. 14, 2019, in open session at Postal Service headquarters, 475 L'Enfant Plaza, SW, Washington, DC. The public is welcome to observe the meeting beginning at 9:00 a.m. ET in the Benjamin Franklin Room on the 11<sup>th</sup> floor. The Board is expected to discuss the following items:

A public comment period will begin immediately following the adjournment of the open session on Nov. 14. During the public comment period, which shall not exceed 30 minutes, members of the public may comment on any item or subject listed on the agenda for the open session above. Onsite registration will be available until thirty minutes before the meeting starts. No more than three minutes shall be allotted to each speaker. The time allotted to each speaker will be determined after registration closes. Participation in the public comment period is governed by 39 C.F.R. 232.1(n).
