Subject: Charges against Phil Khong Local President and Will Khong Maintenance Craft Director Southwest Coastal Area Local (SWCAL).

Who is being charged?

Phil Khong Local President SWCAL and Will Khong Maintenance Craft Director SWCAL

Exact Nature of Violation:

Phil Khong and Will Khong have denied me access to the Local Phone System.

Phil and Will Khong changed the key to the union office and failed to provide me a key or access to the union office.

Will Khong cut my regular workday (Tuesday) and stated I would work only one day each week until the end of her term of office and he said he was acting on behalf of Phil Khong.

They denied me access to the local's postage meter and copy machine. They changed the postage code and added a code to the copier. This was discovered on December 18, 2019, when I needed to use them. If fact when I tried to copy I could not and when I needed to copy Will Khong reviewed what I was doing.

I am also denied access to the local union's mailbox.

I fill out vouchers and checks and they are delayed or ignored. This is intended to make me look bad and ineffective and undermined me.

Phil Khong and Will Khong has denied me access to union e mail account when I am not in the office.

Phil Khong called in the payroll because I was denied access to the union office on Tuesday. Tuesday is the normal day to call in the pay. It has been changed to Wednesday and Phil Khong tried to by-pass me on January 8, 2020.

All actions by Phil Khong and Will Khong are intended to undermine me as the elected Secretary Treasurer of the Southwest Coastal Area Local. In the past they have tried to assign my duties to Will Khong and Phil Blas. Phil Khong requested former Secretary Treasurer Frank Townsend to train Phil Khong (himself), Will Khong, and Trustee Nancy Tavera to perform my elected constitutional duties.

Recieved 01-09-2020 Wifima m. Arriaga Phil Khong and Will Khong also have been spreading a lie saying I was the reason for the Annual Dinner Dance cancellation.

Phil Khong and Will Khong deny me offices supplies to allow me to perform my Secretary Treasurer duties.

Phil Khong and Will Khong denied me the opportunity to keep a complete and correct record of the proceedings of this Area Local. As required, I am to produce at all meetings the minutes of past meetings for the purpose of ready reference, and an upto-date copy of the Constitution and By-Laws and they deny me this opportunity.

Phil Khong and Will Khong denied me the opportunity to perform my Secretary Treasurer responsibility, The Secretary-Treasurer shall establish and maintain a proper accounting system that will reflect the financial standing of the Area Local, and will furnish a statement of income and expenditures for the month just past at each meeting. The Secretary-Treasurer will collect all monies due this Area Local and is responsible for all disbursements. The Secretary-Treasurer shall prepare such forms and make such reports to the American Postal Workers Union, AFL-CIO, at the National and State levels as may be requested and will prepare such forms and reports for the United States Department of Labor and the Internal Revenue Service or any other governmental agency or department as may be required by law. The Secretary-Treasurer will perform such other duties consistent with the offices as may be directed by the President.

Phil Khong and Will Khong violated my Members Bills of Rights items 1, 2, 3, 6, and 10 and Article 2 Section 1 of the Constitution and I am being discriminated based on my sex and race.

Phil Khong and Will Khong denied me supplies and my expenses to the Secretary Treasurer Meeting in October of 2019.

Everything that has occurred is intended to affect the 2020 Local Elections. Phil Khong and Will Khong want all members to have a negative impression of me so they will not support my re-election.

Time Period of Violation:

October 2, 2019, to present time and beyond (continuing). All allegations are within 120 days period as stated in Article 15 of the National APWU, AFL-CIO.

Constitutional provision being violated:

Southwest Coastal Area Local Constitution Provisions:

Member's Bill of Rights

- 1. Every member has the right to be respected as a human being.
- 2. Every member has the right to be respected as a brother and sister of this Union.
- 3. Every member has the right to freedom of speech and the right to be heard.
- 6. Every member has the right to participate in the activities of this Union.
- 10. Every member has the right to be secure in his basic rights without fear of political, economical, physical, or psychological intimidation.

Article 2

Purpose and Aim

SEC. 1. The object of this Area Local shall be to advance the interest of the Postal Service employees regardless of sex, age, race, color, creed, religion, political affiliation, or national origin: to unite the postal workers into a bona fide labor union for their social and economic advancement and their mutual welfare; and to improve the efficiencies of the Postal Service.

Article 8 Section 3

SEC. 3. The Secretary-Treasurer shall keep a complete and correct record of the proceedings of this Area Local. He shall perform such duties as may be assigned by the President. He shall be required to produce at all meetings the minutes of past meetings for the purpose of ready reference, and an up-to-date copy of the Constitution and By-Laws.

The Secretary-Treasurer shall call a meeting of the Executive Board within ten (10) days after notification that the absence of the President will be of a permanent nature:

the purpose of the meeting being to take necessary action to elect a new President: this election will be conducted in the following manner:

- (A) Nominations and elections at this Special Executive Board Meeting.
- (B) A two-thirds (2/3) majority vote of the Executive Board present shall prevail in the selection. Where there are more than two candidates for the position of President, the candidate receiving the lowest vote will not be eligible for the next ballot. The new President will assume the duties of the office at the close of this meeting.

The Secretary-Treasurer shall establish and maintain a proper accounting system that will reflect the financial standing of the Area Local, and will furnish a statement of income and expenditures for the month just past at each meeting. The Secretary-Treasurer will collect all monies due this Area Local and is responsible for all disbursements. The Secretary-Treasurer shall prepare such forms and make such reports to the American Postal Workers Union, AFL-CIO, at the National and State levels as may be requested and will prepare such forms and reports for the United States Department of Labor and the Internal Revenue Service or any other governmental agency or department as may be required by law. The Secretary-Treasurer will perform such other duties consistent with the offices as may be directed by the President.

Article 13 Disbursements

SEC. 5. (A) Any fully paid delegate of this Area Local to conventions and other union assemblies shall be paid for cost of travel to be reimbursed at the rate allowed by the Internal Revenue Service for private conveyance, or all cost of commercial conveyance whichever is cheaper, all lodging, and all registration fees. The amount for meals shall be determined by the general membership, not to exceed the amount allowed by the Internal Revenue Service. He shall be paid that money which he would have received had he been in a normal duty status.

Article 14 Charges

Refer to Article 15 of the *National APWU Constitution and Bylaws* as amended August 16, 2002.

National APWU Constitution:

MEMBERS' BILL OF RIGHTS

1. Every member has the right to be respected as a human being.

- 2. Every member has the right to be respected as a brother or sister of this Union.
- 3. Every member has the right to freedom of speech and the right to be heard.
- 4. Every member has the right to the freedom to listen.
- 5. Every member has the right to the freedom of the press.
- 6. Every member has the right to participate in the activities of this Union.
- 7. Members shall not be denied the right to seek any office or the right to vote in this Union because of race, color, creed, sex, sexual orientation, nationality, handicap, political affiliation, age or religion.
- 8. Every member has the right to support the candidate of his/her choice and to participate in that right with others.
- 9. Every member has the right to a fair trial, to be represented by an individual of his or her choice and

to proper appeal procedures.

10. Every member has the right to be secure in his or her basic rights without fear of political, economic, physical or psychological intimidation.

ARTICLE 15 Local and Membership Protection

- SEC. 3. (a) The National Executive Board of this Union shall have jurisdiction to hear and determine any and all charges under this Article or the Constitution.
- (b) The Executive Board or trial board of local unions or other subordinate bodies have jurisdiction only to hear charges against members or officers of such subordinate body. In cases where charges involving members or officers of a subordinate body are presented to the National Executive Board, it shall refer such charges to the subordinate body involved for a hearing.
- (c) MEMBER CHARGES. A charge by a member in good standing that a member has violated the national Constitution or Bylaws or the Constitution or Bylaws of a local, state or regional organization must be specifically set forth in writing and signed by the member making the charge. For each alleged offense, the charge shall state (1) who is being charged; (2) the exact nature of the alleged offense; (3) the period of time during which the alleged offense took place and (4) the constitutional provision allegedly violated. Attached to the charge(s) will be evidence and if there are witnesses, a signed statement from at least one (1) witness.
- (d) Except in cases of suspension or expulsion for non-payment of dues or per capita, no disciplinary action shall be taken for violation of any of the provisions of this Article or of the Constitution until an accused individual or a subordinate body has been accorded the following procedures.
- (e) Proceedings under this Article may be initiated by any member of APWU by filing charges with the Secretary of the body of which the accused is an officer or member.
- (f) PROCEDURES. Charges must be submitted to the Secretary-Treasurer or Treasurer, or, if the Secretary Treasurer and Treasurer are charged, then to the highest-ranking officer not charged, of the local, state or regional organization of which the

charged member or officer is a member, with the exception of national officers. Charges against a national officer are to be submitted to the national Secretary-Treasurer or the highest-ranking officer not charged. All charges are to be submitted within one hundred twenty (120) days of the time the charging party first became aware, or reasonably should have been aware of the alleged offense. Upon receipt of the charges, the Secretary-Treasurer or Treasurer of the local, state or regional organization or highest-ranking officer not charged with whom such charges are filed shall promptly transmit by express mail or certified mail, including a return receipt, a copy of the charges to the charged and charging parties at the last known address of each. Accompanying the charges shall be written notice of the time and place of the hearing, which shall be held not less than one (1) week after the date of mailing of the notice. In the event of a trial board being appointed pursuant to Section (i), such notice of hearing shall be given to the accused by the committee.

- (g) The accused shall be accorded a full and impartial trial, with the right to appear personally and be represented by any member of this Union, but whether the accused shall be represented by an attorney in such trial shall be left to his or her own discretion.
- (h) The hearing may be held on a charge notwithstanding the failure of the accused, after being given notice thereof pursuant to provisions of this Article to appear thereat.
- (i) The National Executive Board shall constitute a trial board before which hearings on the charges before the National Executive Board may be held provided that the National Executive Board may appoint a hearing officer or officers to act on its behalf for the purpose of holding a hearing. The National Executive Board may appoint as a hearing officer one (1) or more national Union officer(s) who shall be impartial. In cases in which a hearing officer is appointed by the National Executive Board, the hearing officer shall hold a trial under such trial procedure as shall be determined by the National Executive Board; shall make findings of fact and conclusions of law in respect to such charges; and shall recommend to the National Executive Board what disciplinary action, if any, is to be taken by the National Executive Board. In all cases, including those in which a hearing officer is appointed by the National Executive Board, the National Executive Board shall determine what disposition should be made of the charges before it.
- (j) The local or state executive board or separate elected trial board for a subordinate body shall constitute the trial board before which hearings on charges may be held, provided that any such trial board may appoint one (1) or more of its members who shall be impartial to act for it as hearing officer for the purpose of holding hearings. In cases in which a hearing officer is appointed, the hearing officer shall hold a trial under such trial procedure as shall be determined by the trial board; shall make findings of fact and conclusions of law in respect to such charges; and shall recommend to the trial board what disciplinary action, if any, is to be taken by the trial board. In all cases, including those in which a hearing officer is appointed, the trial board shall determine what disposition should be made of the charges before it.

- (k) Any decision or disposition of charges by the Executive Board or separate elected trial board of a local union shall be reduced to writing and submitted as a report to the Secretary of the local union, including a synopsis of the testimony introduced at the trial, together with the verdict "guilty" or "not guilty," and the recommended disciplinary action, if any. Upon receiving the report, the Secretary of the local union shall read it at the next regular union meeting. In the event of a guilty verdict, the Secretary will first submit the question of sustaining the report as to guilt or innocence and if guilt is determined, then the question of accepting or rejecting the recommended disciplinary action. However, if the recommended disciplinary action is expulsion, suspension without pay in excess of sixty (60) days or termination of an incumbent elected officer. an affirmative vote to expel from office or terminate the membership of the officer cannot take effect unless confirmed by two-thirds (2/3) of those voting in a referendum on the recommended disciplinary action. The affected officer shall have ten (10) days to submit a reply to the report. The report and the reply from the affected officer, if submitted, shall contain no more than one thousand (1,000) words each and be sent with each ballot.
- SEC. 4. (a) Any person or body against whom disciplinary action has been taken or whose charges have been dismissed in whole or in part, shall have the right to appeal as follows:
- (b) From the disciplinary action of or dismissal of charges by a local union, (1) to the President, (2) to the National Executive Board, and (3) to the National Convention.
- (c) From the disciplinary action of or dismissal of the charges by the National Executive Board to the National Convention.
- (d) From the disciplinary action of the President (1) to the National Executive Board, and (2) to the National Convention.
- (e) In acting as an appeal board, the National Executive Board may appoint one (1) or more national Union officer(s), who shall be impartial, to act on its behalf for the purpose of reviewing any appeal. The member so named shall make recommendation to the National Executive Board concerning disposition of the appeal. The National Executive Board shall determine the final disposition of the appeal.
- (f) Appeals shall be taken within a reasonable time not to exceed thirty (30) days from the date that notice of disposition of the charges or disposition of any intermediate appeal is received, provided the appellate body may extend such time for appeal if circumstances so warrant. Appeals shall be in writing and shall state the basis of the appeal. The appellant shall be permitted to present such appeal in person before any appellate tribunal. In the case of an appeal to a National Convention, such personal appeal shall be limited to an appearance before the Convention Committee established to deal with appeals unless such appeals committee or the convention itself decides to permit a personal appearance before the National Convention.

This letter is submitted to you as my formal request for the Agency to approve Leave Without Pay -- Union Official (code 084) for duty elected Area Local Secretary-Treasurer Monica Garcia. EYEWITNESS STATEMENT

On Saturday April 27, 2019 APWU held an Executive Board meeting followed by the General Membership Meeting. This statement is in regards to the General Membership meeting that took place.

The meeting started out with everything according to plan and was for the most part fairly smooth. It was towards the end of the meeting that things got hectic and heated.

Proposals of the Amendments were read and many people had different opinions. The discussion on the subject matter got heated and members were starting to yell at each other.

Two members in particular (Frank Townsend and Tony Edwards) got into each other's face and created an environment that was becoming hostile. The president left the Chair and walked over to the two members in conflict (which was approximately 10 feet away from the Chair).
