This is an informational notice of the Postal Service's intent to conduct Mail Processing Facility Review (MPFR) studies in:

In accordance with Handbook PO-408, *Mail Processing Facility Review*, an MPFR determines the feasibility of changing mail processing operations to improve operational efficiency and/or service. An MPFR involves the consolidation of all originating and/or destinating distribution operations from one or more Post Offices/facilities into other automated processing facilities for the purpose of improving operational efficiency and/or service. - Wilmington, DE P&DC into Philadelphia, PA P&DC
