This is in further reference to the Postal Service's July 29, 2022 correspondence (enclosed) concerning establishment of Sorting and Delivery Centers (S&DCs). The purpose of establishing S&DCs is to reduce transportation and mail handling costs as well as provide postal customers with additional services. S&DCs will allow for easier standardization and management of operations will have improved building and operating conditions for employees.

Dear Mark:

Consistent with the Postmaster General's 10-year plan, *Delivering for America*, the Postal Service intends to create Sorting and Delivery Centers (S&DCs). Initially, S&DCs will include both processing and delivery operations but may expand to include other operations in the future.

The purpose of creating S&DCs is to reduce transportation and mail handling costs, as well as provide postal customers with additional services. S&DCs will allow for easier standardization and management of operations while improving building and operating conditions for employees. This notice follows management's July P&DC briefing on the Postmaster General's Modernization Plan. The Plan will ultimately include S&DCs, RP&DCs and LDCs.

This notice is to provide you with additional information and confirm the Postal Service has identified the following 10 initial sites for the initial conversion into S&DCs:

- Mid Hudson Processing and Distribution Center (P&DC)
- Utica Processing and Distribution Facility (P&DF)
- Southeastern P&DC
- Kalamazoo P&DC
- Gainesville P&DF
- Athens P&DC
- Columbus Main Office
- Northpark Station (Topeka)
- Newcastle P&DF
- Bryan P&DC

Additional information will be shared with you in the coming weeks. Any movement of employees and related regional and/or local notifications will be done in accordance with the respective collective bargaining agreements.
